3.13 MANDATORY FARE QUOTE AND ENFORCED TICKET TIME LIMIT — TIME LIMIT AUTO CANCEL (for Exemption)

Based on RP1768a — Mandatory Fare Quote and Enforced Ticket Time Limit, a Member may exempt a PNR from automatic cancellation by a Member/CRS.

Components of this SSR are:

- (a) Supplementary Item Identifier SSR;
- (b) Special Service Requirement Code TLAC;
- (c) Action Identifier enter the airline designator of the airline/CRS to take action;
- (d) Oblique
- (e) The airline designator of the airline authorising the exemption;
- (f) The word EXEMPT
- (g) Free text area (optional) --- shall be preceded by a period (.).

Example of airline exempting a CRS auto cancel of inventory:

Note: Inclusion of the air segments is optional.

□ 3.14 ADVANCED PASSENGER INFORMATION — API (bilateral agreement only)

Information may be exchanged when a passenger/crew is travelling on an international segment(s). The supplementary element — Special Service Requirement (SSR) — follows the general construction rules as stated in 2.11 through 2.11.5.13.

Separate SSR items are required for each passenger and crew member, if applicable.

SSRs may be segment associated using automated format or may apply to all segments for the actioned carrier using non-automated format.

Airline code "YY" is not permitted.

The agreed maximum set of data elements for the transmission of the advanced passenger information (API), as defined by the WCO/IATA/ICAO Advanced Passenger Information Guidelines (Section 8), are summarised as follows:

3.14.2 API — Passenger/Crew Other Travel Related Information (bilateral agreement only)

3.14.2.1 Definitions

Visa and Place of Birth the elements that may be included as part of the other travel related information.

A Visa is considered a secondary travel document and must be used in conjunction with a primary document such as a Passport.

Element (f) Passenger/Crew Place of Birth requires manual data capture methods as it is located in the visual zone of a passport and is identified using the full place name. Place of Birth may also include the country code.

The data capture of the MRZ date formats (YYMMDD) must be converted to AIRIMP standards (DDMMMYY) prior to the transmission of the SSR element and converted back to YYMMDD when using the WCO/IATA PAXLST message.

The data capture of MRZ Country/State Code (3 alphabetic) may need to be converted to the AIRIMP standards of 1-3 alphabetic characters and converted back to the 3 alphabetic code (aaa) when using the WCO/IATA PAXLST message.

Element (j) Visa issuing Country/State must be provided in situations where a passenger is travelling to two or more Countries/States requiring separate Visa documents. This element is a data collection requirement and is needed in order to provide the correct Visa information for the relevant Country/State information.
